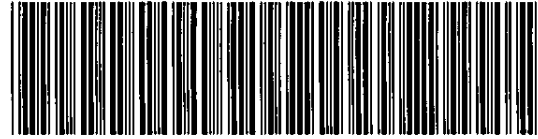

### **ARTICLE I**

#### **NAME**


office, or both, from time to time without amendment of these articles of organization.


