

- I. The name of Shore USA, L.L.C. is hereby amended to Love Shore, LLC.

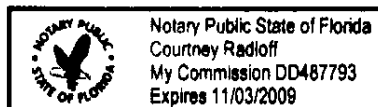
