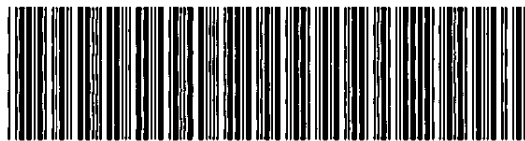

ARTICLES OF ORGANIZATION
OF
Planet Pet Animal Hospital, L.L.C.
(a Florida Limited Liability Company)

The undersigned certifies that I have organized for the purpose of becoming a limited liability company under the laws of the State of Florida, providing for the formation, rights, privileges and immunities of limited liability companies.

ARTICLE I
(Name and Principal Place of Business)

The name of the limited liability company is Planet Pet Animal Hospital, L.L.C., and the mailing address and street address of its principal office is 1800 Finch Lane, Vero Beach, Florida 32962.

ARTICLE II
(Duration)

The limited liability company shall come into being upon the filing of the Articles of Organization with the Secretary of State, State of Florida, and shall have perpetual existence, unless earlier terminated by operation of law or as provided in these Articles or the Operating Agreement of the limited liability company.

ARTICLE III
(Initial Registered Office and Registered Agent)

The mailing address of the registered office of the initial registered agent is 1800 Finch Lane, Vero Beach, Florida, 32962. The name of the company's initial registered agent at that address is Melissa Mueller.

ARTICLE IV
(Membership Restrictions - Admissions)

Additional persons or entities may be admitted to the limited liability company as members

upon the unanimous consent of the current members and on such terms and conditions as determined by the members and in accordance with these Articles and the Operating Agreement of the limited liability company. This limited liability company shall be governed by the provisions of Chapters 621 of the Florida Statutes.

ARTICLE V
(Right to Continue Business)

On the death, withdrawal, resignation, expulsion, bankruptcy or dissolution of a member, or the occurrence of any other event which terminates the continued membership of a member in the limited liability company, the remaining members shall have the right to continue the business on the consent of a majority (or all) of the remaining members within ninety (90) days of the terminating or dissolving event.

If any member, officer, agent, or employee, of this company who has been rendering professional service to the public becomes legally disqualified to render such professional service to the public within the state, said member shall cease practicing as part of this Company. Failure to require compliance with this provision shall constitute a ground for the judicial dissolution of the limited liability company. All professional services provided by this company shall be rendered by a licensed professional.

ARTICLE VI
(Management)

The limited liability company shall be managed by one manager. The name and address of the person who shall serve until the first annual meeting of members is as follows: Melissa Mueller, 1800 Finch Lane, Vero Beach, Florida 32962.
