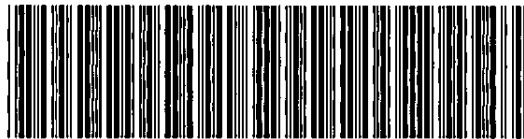

Name**

The name of the Limited Liability Company is Ho Ho Investments, LLC (the "Company").
