


FINAL JUDGMENT OF DISSOLUTION OF MARRIAGE

THIS CAUSE having come on for final hearing on the 13th day of November 2008, and the Court having heard the testimony of the Petitioner and having received sufficient evidence that the Petitioner is in compliance with the residency requirement set forth by law, and the Court finding that the marriage is irretrievably broken, and being otherwise fully advised in the premises, it is hereby:

## ORDERED AND ADJUDGED as follows:

- 1. That this Court has jurisdiction of the parties and of the subject matter of this cause.
- 2. That the marriage is irretrievably broken.
- That the marriage between the Petitioner, ALFRED BERNARD TERPPE, and the Respondent, SUSAN M. TERPPE, is hereby dissolved and the parties and each of them are forever free from the bonds of matrimony existing between them.
- 4. The parties' entered into an agreement in open court on November 13, 2008. The Court entered the Order Adopting Agreement on December 5, 2008. That the Order Adopting Agreement shall be incorporated into the Final Judgment of Dissolution of Marriage. A copy of the Order Adopting Agreement is





attached as exhibit "A".

- That pursuant to the Order Adopting Agreement, that the former name of the Wife is hereby restored and she shall henceforth be known by the name of SUSAN MARIE BARNARD.
- 6. This Court retains full and complete jurisdiction of this cause of action and the parties, except for the actual dissolution of marriage, for the purpose of entering such further orders as may be necessary for the purpose of enforcing the provisions of this Final Judgment as well as any other matters permitted by law.
