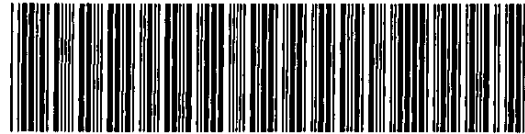

ARTICLE VII – MEMBERS RIGHTS TO CONTINUE BUSINESS:


