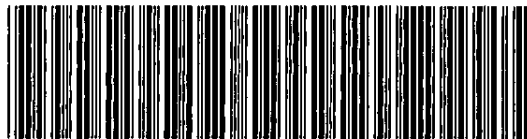

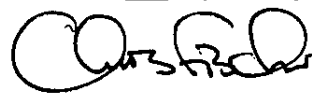
ARTICLE VIII

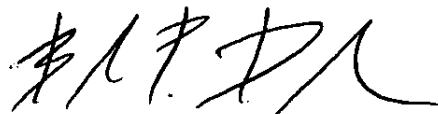
