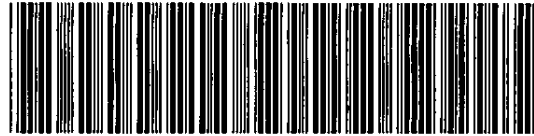



ARTICLES OF ORGANIZATION
OF
SONGUR INTERNATIONAL MORTGAGE LLC

The undersigned, for the purpose of forming a limited liability company under the Florida Limited Liability Company Act, Florida Statute Chapter 608, hereby makes, acknowledges, and file the following Articles of Organization.

ARTICLE 1 - NAME

The name of the limited liability company shall be **SONGUR INTERNATIONAL MORTGAGE LLC**, ("Company").

ARTICLE 2 - ADDRESS

These Articles of Organization shall be effective May 16th, 2007 upon approval of the Secretary of State, State of Florida.


