STUDER COVENANT ALLIANCE, LLC, a Florida limited liability company (the "LLC"), files these Articles of Dissolution evidencing the LLC's dissolution and discontinuation of business, and sets forth the following pursuant to the provisions of Section 608.445, Florida Statutes:

1. The name of the LLC is STUDER COVENANT ALLIANCE, LLC.
2. The Articles of Organization of the LLC were filed on May 21, 2007 and assigned document number L07000053746.
3. The dissolution was approved by the Members of the LLC on August 20, 2013 by execution of the Agreement for Dissolution, effective August 31, 2013.
4. The effective date of the dissolution of the LLC is August 31, 2013.
5. Pursuant to Section 608.441(1)(c), Florida Statutes, the occurrence of the event that resulted in the dissolution of the LLC was the unanimous vote of the Members of the LLC to discontinue the operations of the LLC and to dissolve the LLC in accordance with the terms of the Agreement of Dissolution entered into between the Members and the LLC, effective August 31, 2013.
6. All debts, obligations and liabilities of the LLC have been paid or discharged.
7. All remaining property and assets have been distributed among its Members in accordance with their respective rights and interests and the terms of the Agreement of Dissolution, effective August 31, 2013.
8. There are no suits pending against the LLC in any court.
