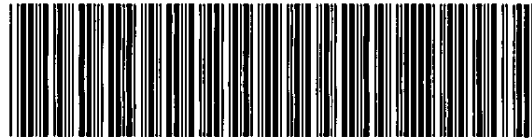

ARTICLE 1 - NAME

The name of the limited liability company shall be **KL PROPERTIES BRAZIL, LLC**, ("Company").

ARTICLE 2 - ADDRESS

The principal place of business of the Company in Florida shall be 5035 Hammock Lake Drive, Coral Gables, Florida 33156 and the mailing address shall be the same.

ARTICLE 3 - EFFECTIVE DATE

These Articles of Organization shall be effective immediately upon approval of the Secretary of State, State of Florida.

ARTICLE 6 - REGISTERED OFFICE AND REGISTERED AGENT

whose mailing addresses shall be the same as the principal office of the Company.



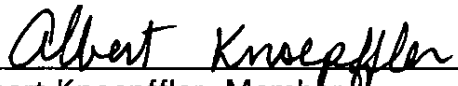

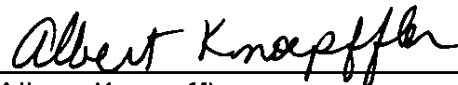
