ARTICLES OF ORGANIZATION OF STRINGER PROPERTIES, LLC

ARTICLE I - NAME

The name of this Limited Liability Company is STRINGER PROPERTIES, LLC.

ARTICLE II - ADDRESS AND PRINCIPAL PLACE OF BUSINESS
