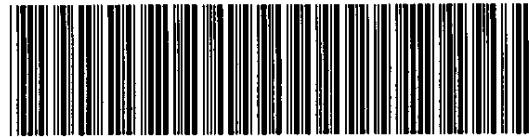

1. The name of the organization is currently MARINA BLUE 3304 LLC.
2. The date of the filing of the Articles of Organization was May 22, 2007 and the company was assigned Document number: L07000054527.
3. The date of the filing of the first Articles of Amendment was January 17, 2008 to change the name from Merrick Retail 6 LLC to Marina Blue 3304 LLC.
