**ARTICLES OF ORGANIZATION
OF
NORMAN HIGH FENCING TEAM, LLC**

The undersigned, for the purpose of forming a limited liability company under the Florida Limited Liability Company Act, Chapter 608, Florida Statutes, hereby makes, acknowledges, and files the following Articles of Organization.

ARTICLE I - NAME

The name of the limited liability company shall be NORMAN HIGH FENCING TEAM, LLC (the "Company").

ARTICLE II - ADDRESS

The mailing address and street address of the initial principal office of the Company shall be 5256 Coral Wood Drive Naples FL 34119.

ARTICLE III - DURATION

The Company shall commence its existence on the date these articles of organization are filed with the Florida Department of State. The Company's existence shall be perpetual unless the Company is earlier dissolved as provided in these articles of organization or in the Company's operating agreement.

ARTICLE IV - REGISTERED OFFICE AND AGENT

ARTICLE V - ADMISSION OF NEW MEMBERS

No additional members shall be admitted to the Company except with the prior unanimous written consent of all members and on such terms and conditions as shall be unanimously approved in writing by all members. A member may transfer its interest in the Company only as set forth in the Operating Agreement of the Company.

ARTICLE VI - WITHDRAWAL OF MEMBERS

A member of the Company may withdraw from the Company only upon the unanimous prior written consent of all the nonwithdrawing members of the Company.

ARTICLE VII - TERMINATION OF EXISTENCE

The Company shall be dissolved upon the occurrence of events specified in the Company's Operating Agreement.
