
ARTICLE VI:

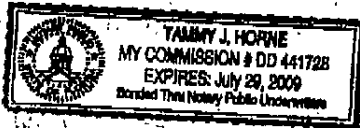
