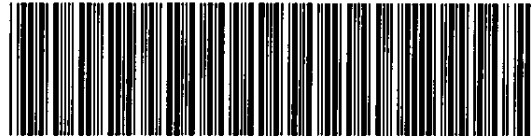

**ARTICLES OF ORGANIZATION
OF
ADVANCED UROLOGICAL TECHNOLOGIES, L.L.C.**

The undersigned being above the age of eighteen (18) years of age and competent to contract, for the purposes of organizing a limited liability company pursuant to Chapter 608, Florida Statutes, and the laws of the State of Florida, does hereby adopt the following Articles of Organization for Advanced Urological Technologies, L.L.C. (the "Company"), and does hereby agree and certify as follows:

**ARTICLE I
NAME & PRINCIPAL OFFICE**

The name of this Company shall be Advanced Urological Technologies, L.L.C. and its principal place of business shall be located at 1461 Shady Meadow Lane, DeLand, FL 32724.

**ARTICLE II
DURATION**

The duration of the Company shall be perpetual unless sooner dissolved according to law.

**ARTICLE III
GENERAL PURPOSE: GENERAL POWERS**

The Company is authorized to conduct all lawful business activities permitted under Florida law and shall have and be allowed to exercise all powers necessary or convenient to affect its general purpose. Also, it is hereby expressly provided that the foregoing general purposes shall not be held to limit or restrict in any manner the purposes of the Company otherwise permitted by law.

**ARTICLE IV
REGISTERED OFFICE AND REGISTERED AGENT**

The initial registered office of this Company shall be located at 6100 Minton Road, Palm Bay, Florida 32907, and the initial registered agent of the Company at that address shall be John Pearson, M.D. The Company may change its registered agent or the location of its registered office, or both, from time to time without amendment of these Articles of Organization.

**ARTICLE V
MEMBERS/MANAGEMENT**

The Company is authorized to initially issue 100 membership units each with a value of \$1000. The Company is to be member managed with the initial members and member managers and their names and membership interests as follows:

(Member with 15 membership units)

(Member with 15 membership units)

5. Prostate Treatment Centers, L.L.C.
(Managing member with 15 membership units)

**ARTICLE VI
INDEMNIFICATION OF OFFICERS, DIRECTORS AND MANAGERS**

The Company shall be authorized to indemnify and hold harmless its officers, directors and managers in accordance with the provisions of Section 608.4229, Florida Statutes.

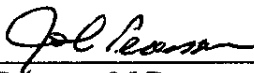
**ARTICLE VII

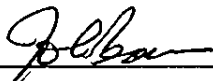
