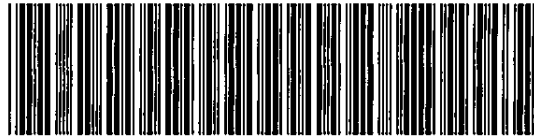



ARTICLE V


