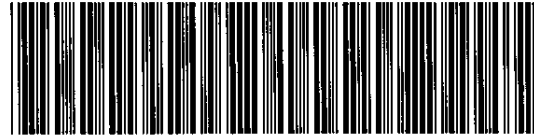

Pursuant to Section 608.407 of the Florida Limited Liability Company Act, the undersigned, as the Managing Member of ScanAmerican Group, LLC, does hereby make, subscribe, acknowledge and file these Articles of Organization for the purpose of becoming a Limited Liability Company under the Laws of the State of Florida.

ARTICLE I. NAME

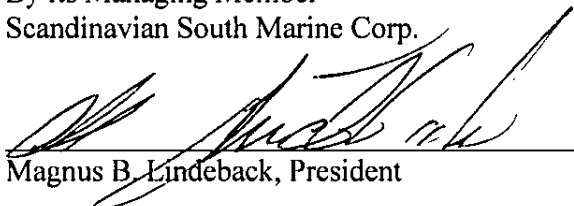

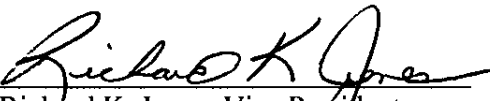
