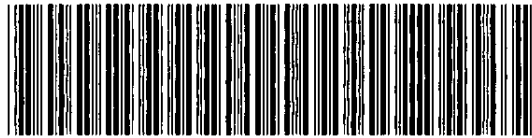


Dear Mr. Christopher Amore:
