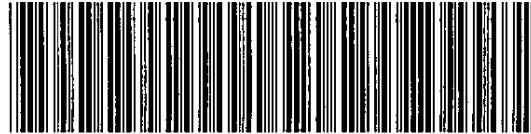



ARTICLE IV: MEMBERS


