**ARTICLES OF AMENDMENT TO  
ARTICLES OF ORGANIZATION OF  
FLORIDA RELOCATION OPTIONS, LLC  
(A Florida Limited Liability Company)**

Pursuant to Section 608.411, Florida Statutes, **FLORIDA RELOCATION OPTIONS, LLC**, a Florida limited liability company (the "**Company**"), hereby adopts the following amendment to its Articles of Organization:

**FIRST:** The Articles of Organization were filed on May 30, 2007, and assigned document number L07000056904.

**SECOND:** Article II of said Articles of Organization is hereby amended in its entirety to change the address of the Company from "4250 Alafaya Trail, Suite 212-159, Oviedo, FL 32765" to a street address of "7901 Kingspointe Parkway, Suite 30, Orlando, Florida 32819" and a mailing address of "205 S. Dixie Drive, #2001, Haines City, Florida 33844", by deleting the provision of said Article II as the same now exists and by substituting in lieu thereof, the following:

**"ARTICLE II - ADDRESS**

The street address of the principal office of the Company is 7901 Kingspointe Parkway, Suite #30, Orlando, Florida 32819, and the mailing address is 205 S. Dixie Drive, #2001, Haines City, Florida 33844."

**THIRD:** Article IV of said Articles of Organization is hereby amended to change the registered office of the Company from "4250 Alafaya Trail, Suite 212-159, Oviedo, FL 32765" to "3560 Crump Road, Winter Haven, FL 33881", by deleting the provision of said Article IV as the same now exists and by substituting in lieu thereof, the following:

**"ARTICLE IV - REGISTERED OFFICE AND AGENT**

The street address of the registered office of the Company is 3560 Crump Road, Winter Haven, FL 33881, and the name of the registered agent of the Company at that address is Ray Wofford."
