ARTICLES OF ORGANIZATION OF LAKE MARY SURGERY CENTER, LLC

- The name of this limited liability company is LAKE MARY SURGERY CENTER, LLC, a Florida limited liability company (the "Company").
- Duration. The Company shall be effective upon the filing of these Articles and shall thereafter have perpetual existence.
