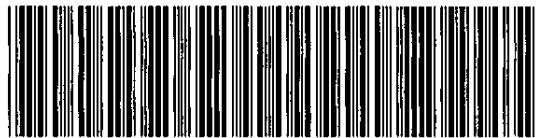



a Florida Limited Liability Corporation.


2. I am the sole managing member of this entity.
