## **ARTICLES OF ORGANIZATION**

The undersigned, for the purpose of forming a limited liability company under the Florida Limited Liability Company Act, Florida Statutes Chapter 608, hereby makes, acknowledges, and files the following Articles of Organization.

### ARTICLE 1 - NAME

The name of the limited liability company shall be **EMERALD COAST PRESSURE WASHING, LLC** ("Company").

#### **ARTICLE 2 - ADDRESS**

The principal place of business of the Company in Florida shall be 3109 Harper Drive, Navarre, Florida 32666 and the mailing address shall be the same.

#### **ARTICLE 3 - EFFECTIVE DATE**

These Articles of Organization shall be effective immediately upon approvation the Secretary of State, State of Florida.

#### **ARTICLE 4 - DURATION**
