

ARTICLES OF ORGANIZATION

OF

DPRFAH, LLC

The undersigned organizer hereby forms a Limited Liability Company under Chapter 608 of the laws of the State of Florida.

ARTICLE I - NAME

The name of the Limited Liability Company ("Company") shall be DPRFAH, LLC.

ARTICLE II - PRINCIPAL PLACE OF BUSINESS

The address of the principal place of business of this Company shall be 6890 Athena Drive, Lake Worth, Florida 33463, and the mailing address of the Company shall be the same.

ARTICLE III - TERM OF EXISTENCE

This Company shall commence its existence on the date these Articles are filed, pursuant to Florida Statutes Section 608.409; and shall exist until dissolved in a manner provided by law or as provided in the operating agreement adopted by the members.

Except as otherwise provided in the operating agreement adopted by the members, no new members shall be admitted without the consent of members owning at least sixty (60%) percent of the voting membership interests.

ARTICLE VI - CONTINUATION OF COMPANY

Except as otherwise provided in the operating agreement adopted by the members, the remaining members of this Company shall have the right to continue the business of the Company upon the death, retirement, resignation, expulsion, bankruptcy or dissolution of a member or the occurrence of any event that terminates the continual membership of a member in the limited liability company, upon the vote of the remaining members owning at least sixty (60%) percent of the voting membership interests.

ARTICLE VII - INITIAL REGISTERED OFFICE AND REGISTERED AGENT




