**ARTICLES OF ORGANIZATION
OF
COUNTRY OAKS VETERINARY CLINIC, PLLC**

The undersigned, acting as organizer of this professional limited liability company pursuant to Chapter 621 of the Florida Statutes and a doctor of veterinary medicine licensed to render services as such under the laws of the State of Florida, hereby forms a professional limited liability company under the laws of the State of Florida and adopts the following Articles of Organization for such professional limited liability company:

ARTICLE I - NAME OF COMPANY

The name of the professional limited liability company is Country Oaks Veterinary Clinic, PLLC. (the "Company").

ARTICLE II - PRINCIPAL OFFICE

The initial principal place of business and principal office of the Company shall be 13938 S U.S. Highway 441, Summerfield, FL 34491. The mailing address of the Company shall be 13938 S U.S. Highway 441, Summerfield, FL 34491.

ARTICLE III - REGISTERED AGENT AND REGISTERED OFFICE

The street address of the initial registered office of the Company in the State of Florida is 13938 S U.S. Highway 441, Summerfield, FL 34491. The name of the registered agent of the Company at that address is Frances M. Ramirez, D.V.M.

ARTICLE IV - MANAGEMENT

The Company is to be managed by its members and is, therefore, a member-managed company.

ARTICLE V - GENERAL NATURE OF BUSINESS

The Company shall engage in every phase and aspect of the business of rendering the same professional services to the public that a doctor of veterinary medicine licensed under the laws of the State of Florida is authorized to render, but such professional services shall be rendered only through members, officers, employees and agents of the Company who are duly licensed to practice veterinary medicine under the laws of the State of Florida. It is intended that the Company may conduct and transact any business lawfully authorized and not prohibited by Chapter 608 and Chapter 621, Florida Statutes, as the same may be from time to time amended.

ARTICLE VI - EFFECTIVE DATE

The effective date of these Articles of Organization, and the beginning of the existence of the Company, shall be the date of filing of these Articles of Organization with the Florida Department of State.

The undersigned member has made and subscribed these Articles of Organization this 1st day of June, 2007.
