of  
GULF COAST PROPERTY INVESTMENTS, LLC

These Articles of Amendment are unanimously adopted by all Members of the company to amend the Articles of Organization of Gulfcoast Property Investments, LLC, to be filed with the Florida Department of State, as follows:

## ARTICLE ONE: NAME

The name of the company is Gulfcoast Property Investments, LLC.

## ARTICLE TWO: DATE OF FILING

The Articles of Organization were filed on 1 June 2007 and were effective on 31 May 2007.

## ARTICLE THREE: AMENDMENT

The Articles of Organization are amended by replacing Article Five thereof with the following Article Five:

## ARTICLE FIVE: MANAGEMENT

The company shall be managed by one or more Managers who shall be elected by the Members. Any Manager may be recalled by the Members, provided a new Manager is thereupon simultaneously elected, unless the total number of Managers is simultaneously and correspondingly decreased by proper amendment to the Operating Agreement of the company. The Operating Agreement shall establish the number of Managers and may set forth other provisions consistent herewith regarding their election and responsibilities; until otherwise established thereby, there shall be one Manager.
