**ARTICLES OF ORGANIZATION
OF
NASH & COMPANY NAYLES, LLC**

The undersigned, for the purpose of forming a limited liability company under the Florida Limited Liability Company Act, Chapter 605, Florida Statutes, hereby makes, acknowledges, and files the following Articles of Organization:

ARTICLE I -- NAME

The name of the limited liability company shall be NASH & COMPANY NAYLES, LLC aka "Company".

ARTICLE II -- ADDRESS

The mailing address and principal address of the initial principal officer of the Company shall be 215 Madison Place, Naples, Florida 34104.

ARTICLE III -- DURATION

The Company shall continue its existence on the date these articles of organization are filed by (to) Florida Department of State. The Company's existence shall be perpetual unless the Company is earlier dissolved as provided in these articles of organization or in the Company's operating agreement.

ARTICLE IV -- REGISTERED OFFICE AND AGENT

The name and exact address of the initial registered agent of the Company in the State of Florida are: Naples-Lawstock, Inc., 1395 Panther Lane, Suite 300, Naples, Florida 34109.

ARTICLE V -- ADMISSION OF NEW MEMBERS

No additional members shall be admitted to the Company except with the prior unanimous written consent of all members and on such terms and conditions as shall be unanimously approved in writing by all members. A member may transfer its interest in the Company only as set forth in the Operating Agreement of the Company.

ARTICLE VI -- WITHDRAWAL OF MEMBERS

A member of the Company may withdraw from the Company only upon the unanimous prior written consent of all the non-withdrawing members of the Company.

ARTICLE VII -- TERMINATION OF EXISTENCE

The Company shall be dissolved upon the occurrence of events specified in the Company's Operating Agreement.

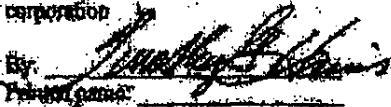

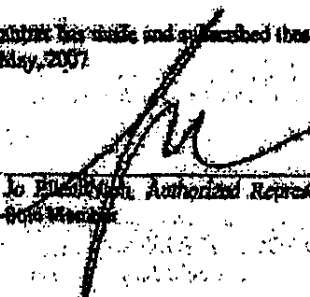
ARTICLE VIII - MANAGEMENT
