THE UNDERSIGNED certifies they intend to form a limited liability company under the laws of the State of Florida and hereby declare that the following Articles shall be the Charter and authority for the conduct of business of such limited liability company.

ARTICLE I
NAME

The name of the limited liability company (the "Company") shall be **MURPHY & JOYCE LTD. CO.**

ARTICLE II
ADDRESS

The mailing and street address of the Company's principal office is 3401 Gulf Shore Boulevard Unit 303, Naples, Florida 34102.

ARTICLE III
PURPOSES

The general nature of the business or businesses to be transacted and which the Company is authorized to transact shall be as follows:

- A. To engage in any activity or business authorized under the Florida Statutes including, but not limited to, the investment, acquisition, sale, development, operation and management of real estate and all matters incidental and related thereto.
- B. In general, to carry on any and all incidental business; to have and exercise all the powers conferred by the laws of the state of Florida, and to do any and all things herein set forth to the same extend as a natural person might or could do.

ARTICLE IV
DURATION

The duration for the Company is perpetual.

ARTICLE V

ARTICLE VI
MANAGEMENT

The Company is to be managed by a member or members.

ARTICLE VII
ADMISSION OF NEW MEMBERS

Members of the Company have the right to admit new members. Additional members may be admitted only on the unanimous written consent of the existing members, and the existing members shall determine the amount and nature of the contribution by new members at the time the new members are admitted.


ARTICLE VIII


