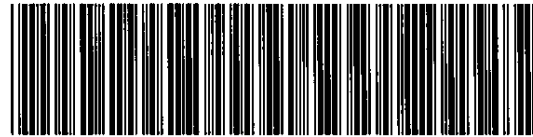




Admission of Additional Members
