**CERTIFICATE OF AMENDMENT  
TO  
ARTICLES OF ORGANIZATION  
OF**

Pursuant to the provisions of section 608.411(2), Florida Statutes, this Limited Liability Company adopts the following Articles of Amendments to its Articles of Organization:

- FIRST:** The date of the filing of the Articles of Organization was June 5, 2007.
- SECOND:** Article 5 of the Articles of Organization of SHOOTING STAR LLC states the Purposes and Powers as:

"The general purpose for which the Company is organized is to engage in the business of sales agent for international airline and to transact any lawful business for which a limited liability company may be organized under the laws of the State of Florida. The Company shall have all the powers granted to a limited liability company under the laws of the State of Florida."
