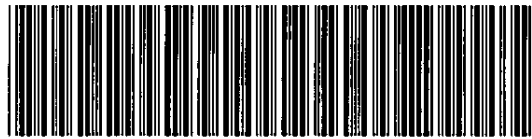

- b. ARTICLE V is deleted and the following is substituted in its place:

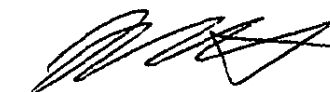
ARTICLE V. MANAGEMENT
