ARTICLES OF ORGANIZATION OF

DOUBLE JJ OF SOUTH FLORIDA LLC

THE UNDERSIGNED, pursuant to the provisions of Chapter 608 of the Florida Statutes, for the purpose of forming a Florida Limited Liability Company (the "Company") under the laws of the State of Florida does set forth the following:

NAME

The name of the Company is:

2. PERIOD OF DURATION

Company may adopt, alter, amend or repeal regulations or any provision thereof upon the affirmative vote of a majority in interest of the members of the Company in attendance at a meeting of the members duly called at which a quorum exists, or by written consent of the members of the Company.
