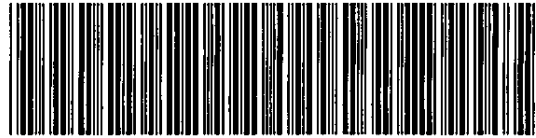

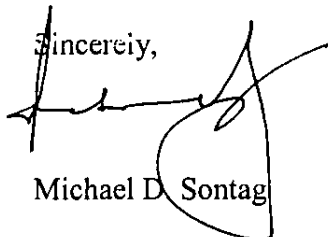

**ARTICLES OF ORGANIZATION

ARTICLE 1

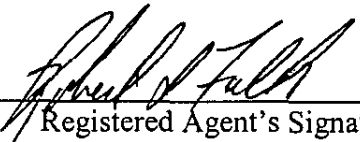
The name of the Limited Liability Company is Falk Equity Management, LLC (the "Company").

The duration of the Company shall be perpetual unless earlier terminated in accordance with the terms of the Operating Agreement of the Company.

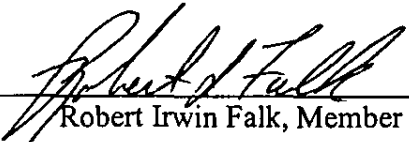
ARTICLE 10
