ARTICLES OF ORGANIZATION OF

RB&BFarm, L.L.C.

(a Florida Limited Liability Company)

pecoming a limited

The undersigned certifies that I have organized for the purpose of becoming a limited liability company under the laws of the State of Florida, providing for the formation, rights, privileges and immunities of limited liability companies.

ARTICLE I

(Name and Principal Place of Business)

The name of the limited liability company is R B & B Farm, L.L.C., and the mailing address and street address of its principal office is 1821 Mooringline Drive, Apt. 3-D, Vero Beach, Florida 32963.

<u>ARTICLE II</u>

(Duration)

The limited liability company shall come into being upon the filing of the Articles of Organization with the Secretary of State, State of Florida, and shall have perpetual existence, unless earlier terminated by operation of law or as provided in these Articles or the Operating Agreement of the limited liability company.

ARTICLE III

(Initial Registered Office and Registered Agent)

ARTICLE IV

(Membership Restrictions - Admissions)

Additional persons or entities may be admitted to the limited liability company as members

upon the unanimous consent of the current members and on such terms and conditions as determined by the members and in accordance with these Articles and the Operating Agreement of the limited liability company.

The limited liability company shall have two (2) classes of voting membership:

<u>Class A</u> – Class A members shall have unrestricted shares. Class A members have the right to buy Class B shares upon the death of a Class B member.

<u>Class B</u> – Class B members shall have restricted shares. Class B members can only leave property to their lineal descendents.

ARTICLE V

(Right to Continue Business)

On the death, withdrawal, resignation, expulsion, bankruptcy or dissolution of a member, or the occurrence of any other event which terminates the continued membership of a member in the limited liability company, the remaining members shall have the right to continue the business on the consent of a majority (or all) of the remaining members within ninety (90) days of the terminating or dissolving event.
