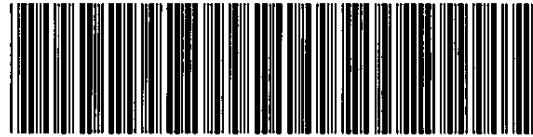

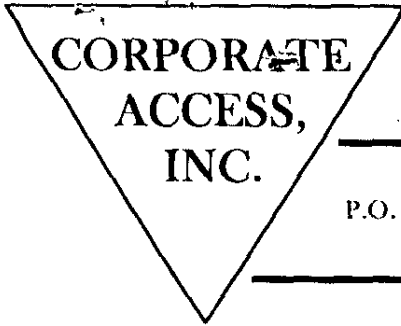


ARTICLE III — Registered Agent and Registered Office:


