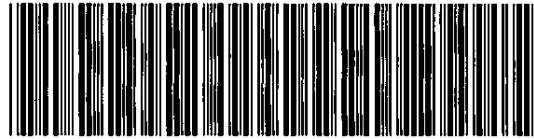

### ARTICLE 1 - NAME

The name of the limited liability company shall be **RLC ENVIRONMENTAL LLC** ("Company").

### ARTICLE 2 - ADDRESS

### ARTICLE 3 - EFFECTIVE DATE

whose addresses shall be the same as the principal office of the Company.

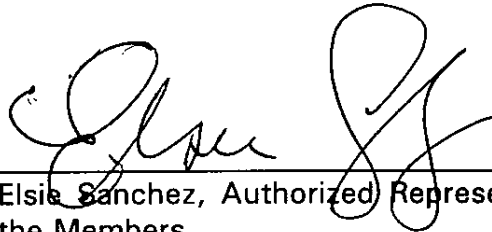

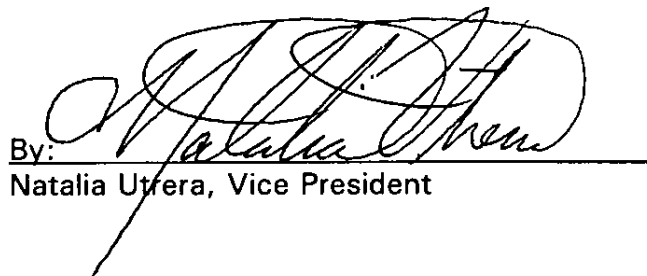
