#### ROBERT T. BRINKLEY, II FAMILY, LLC

- 1. The current name of the Limited Liability Company is Robert T. Brinkley, II Family, LLC.
  - 2. The original Articles of Organization were filed on June 8, 2007.
  - 3. The Articles of Organization are hereby amended and restated as follows:

#### <u>Name</u>
