ARTICLES OF ORGANIZATION
OF
GULFSHORE SURGICAL ASSOCIATES, PL,
A FLORIDA PROFESSIONAL LIMITED LIABILITY COMPANY

The undersigned, for the purpose of forming a professional limited liability company under the Florida Limited Liability Company Act, Chapters 608 and 621, Florida Statutes, hereby makes, acknowledges, and files the following Articles of Organization.

ARTICLE I -- NAME

The name of the professional limited liability company shall be GULFSHORE SURGICAL ASSOCIATES, PL (the "Company").

ARTICLE II -- ADDRESS


ARTICLE VI -- MANAGEMENT
