ARTICLE 1 - NAME

The name of the limited liability company shall be **BUMPERCLEAT, LLC** ("Company").

whose addresses shall be the same as the principal office of the Company.

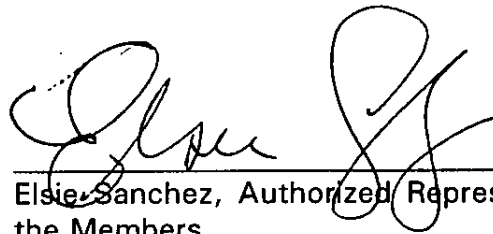
