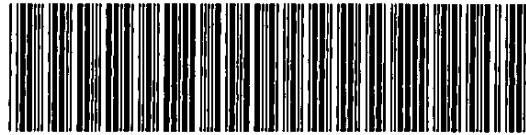



ARTICLES OF ORGANIZATION

THE UNDERSIGNED, for the purpose of forming a professional limited liability company in accordance with the FLORIDA PROFESSIONAL SERVICE CORPORATION AND LIMITED LIABILITY COMPANY ACT to practice the profession of or perform the service of medicine in the State of Florida, hereby adopts the following articles of organization for the company:

FIRST: The name of the company (the "Company") is:
