**ARTICLES OF ORGANIZATION  
OF

**ARTICLE I  
NAME**

The name of this limited liability company is Center of Bonita Partners, L.L.C., a Florida limited liability company (the "Company").

The Company is authorized to issue membership units with voting rights.


