2. Period of Duration. The period of duration for the Company shall be perpetual.

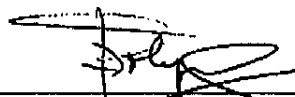
3. Principal Office. The mailing address and street address of the principal office of the Company shall be 209 Avenue O, SW, Winter Haven, Florida 33880.

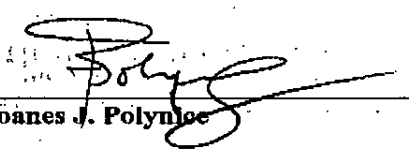

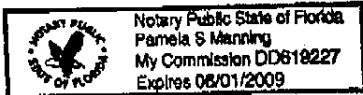
