MEMBERSHIP



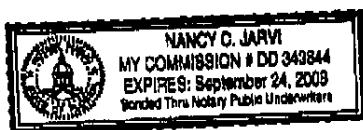


