ARTICLES OF ORGANIZATION

OF

FRESH FROM THE BOAT SEAFOOD LLC

The undersigned, for the purpose of forming a limited liability company under the Florida Limited Liability Company Act, Florida Statutes Chapter 608, hereby makes, acknowledges, and files the following Articles of Organization.

ARTICLE 1 - NAME

The name of the limited liability company shall be FRESH FROM THE BOAT SEAFOOD LLC ("Company").

ARTICLE 2 - ADDRESS

The principal place of business of the Company in Florida shall be 55 Papaya Street, Clearwater Beach, Florida 33767 and the mailing address shall be 452 East Shore Drive, Clearwater, Florida 33767.

<u>ARTICLE 3 - EFFECTIVE DATE</u>

These Articles of Organization shall be effective immediately upon approval of the Secretary of State, State of Florida.
