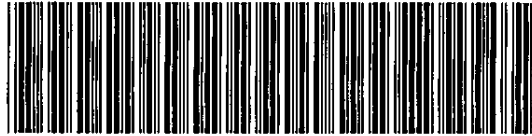

**ARTICLES OF ORGANIZATION
OF
POWER NOW TECHNOLOGIES, LLC**

A Florida Limited Liability Company

The undersigned, pursuant to the provisions of Chapter 608 of the Florida Statutes, for the purpose of forming a limited liability company under the laws of the State of Florida do set forth the following:

ARTICLE 1 – Name: Power Now Technologies, LLC

ARTICLE 2 – Address: The mailing address and street address of the principal office of the Company is: 6240 N.W. 44th Street, Coral Springs, FL 33067

ARTICLE 3 – Registered Agent: The name of the initial registered agent of the Company is Ellen Tabasky. The initial street address of the registered office is 6240 N.W. 44th Street, Coral Springs, FL 33067.

ARTICLE 4 – Management: The limited liability company is to be managed by one manager or more managers and is, therefore, a manager-managed company. The initial manager of the Company is Ellen Tabasky.

ARTICLE 5 – Period of Duration: The period of duration of the Company shall be perpetual.

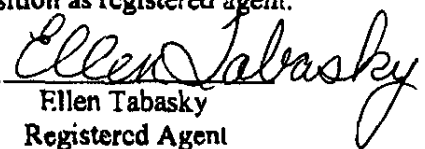
