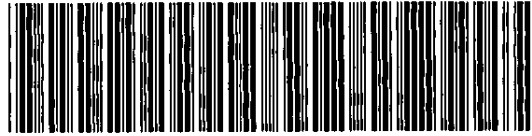



 - a. Article I: NAME is deleted in its entirety and replaced by the following:


