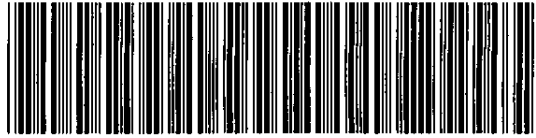


As per my conversation with you, I am hereby requesting that the refund of the


