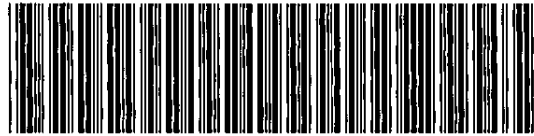

Continuation of Business


