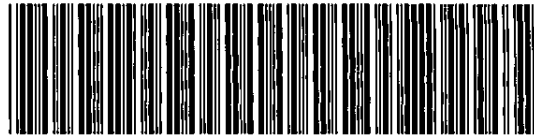

ARTICLE III – DURATION

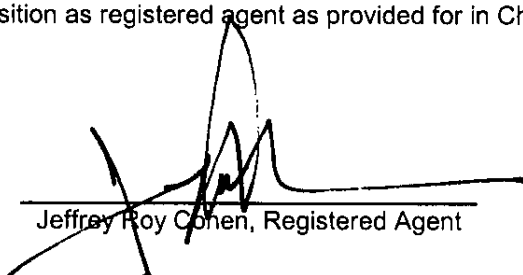

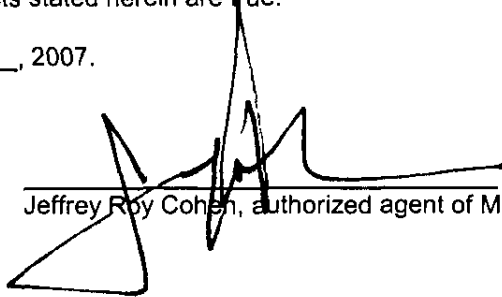

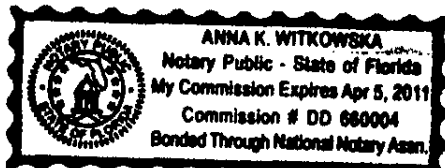
