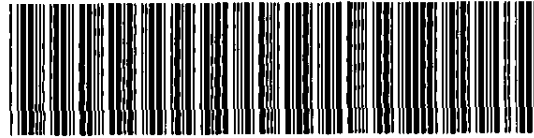

THIRD: The dissolution was approved on May 29, 2010.

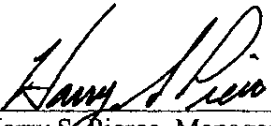
FOURTH: The Company's dissolution pursuant to Section 608.441, Florida Statutes has occurred as a result of the written consent of the sole member of the Company.
